

As we look back on the past year, we are pleased to note the many new legacies created through the Catholic Foundation in the forms of endowments, bequests and estate plans. Twenty-two new funds created this year will impact so many charitable purposes for years to come.

The Foundation is an important part of our Diocese. We are the vehicle through which donors may share gifts and know their intentions will be carefully followed. # ADVANCING THE MISSION




For hundreds of young adults on the west side of Green Bay, finding a place to gather and share their faith has been a blessing. A grant from the Catholic Foundation Advancing the Mission Evangelization Endowment helped the Quad parishes fund their "One Room at a Time" project. This Faith Formation center will provide a place to meet the spiritual and social needs of our youth. The center will also provide religious education classes, parish-wide youth ministry programs and parish events.

The Advancing the Mission campaign established endowments in the areas of Leadership Development, Evangelization, Lifelong Catechesis and Priestly Retirement Care. The campaign raised nearly \$40,000,000 and has distributed more than \$677592.

# BISHOP'S APPEAL

Each year thousands of people across Northeastern Wisconsin come together and share their love of Christ by supporting the Bishop's Appeal.

The Appeal is an annual fundraising campaign conducted by the Catholic Foundation to benefit nearly 300,000 people served by the Church. The 2011 Bishop's Appeal raised \$5,017,000 and was distributed to the follow diocesan departments.



# LUMEN CHRISTI

Imagine being able to share the teachings of the Catholic faith with hundreds of young people. As a high school catechist, Kathy has been called to serve as a leader and role model to this very important population. Through a grant from the Lumen Christi Endowment, Kathy is able to continue her education and help our youth grow in their faith. More than 40,000 children have come to know people like Kathy, who have a great influence on our children's faith lives.

The everlasting impact on today's youth and future generations is just one way the Lumen Christi Endowment makes a difference. Created in 1988, Lumen Christi was established to benefit Catholic education and has since distributed more than \$17 million. This helps fund scholarships for educators to pursue additional training in religious education, provides annual funding to every parish religious education program and to every Catholic school. Over \$663,503 has been distributed this past year and to date the total value of the Lumen Christi endowment of the Catholic Foundation is nearly \$12 million.

# WORLD MISSION SERVICES

World Mission Services promotes the missionary spirit of the Gospel of Jesus Christ.

Our programs, as offered through Catholic Relief Services and the Pontifical Mission Societies, foster global awareness and encourage Catholics in their baptismal call to missionary activity.
