




Bishop's Appeal

Seminarian Collection

The Seminarian Collection invites everyone to participate in the education and formation of our future parish priests. Our seminarians are our hope for the future.

Fr. Alvan Amadi is one of the blessings of that hope. In June 2013, Bishop David Ricken ordained him to priesthood, and he now serves at St. John the Evangelist Parish in Antigo. "I want to preach Christ...to listen to God's people and guide them with gentleness and compassion," Fr. Alvan says. "This is something I want to bring to priesthood."

The Catholic Foundation helps our seminarians each year through the Seminarian Collection. In 2012, the Collection raised more than \$553,768. Seminarians also receive support through four Foundation endowments.

Shrine of Our Lady of Good Help

In 2012, more than 150,000 people from around the country visited the Shrine of Our Lady of Good Help near Green Bay. Like other visitors of the past 150 years, they sought a holy experience, just as young Sister Adele did so many years ago when she had visions of Our Blessed Mother. The Shrine is a welcoming sanctuary of peace, a haven for pilgrims seeking growth and healing.

The Catholic Foundation assists the Shrine's fundraising, which benefits the Shrine's daily operations. It also benefits Shrine ministries, now serving thousands of people. In addition, the Foundation works with friends of the Shrine to establish endowments and to invite people to remember the Shrine in their will.

Planned Giving

Planned Giving is the act of making a charitable contribution where the method and timing benefit both the recipient and the contributor. The recipient can make long-range plans while relying on a dependable source for future funding. And the donor can reap numerous benefits: income tax incentives, guaranteed lifetime income, reduction or elimination of estate taxes, and the satisfaction of making an important charitable gift to a worthy cause, to name just a few.

The possible ways of financing a Planned Gift are nearly limitless. They include:

- Paid-in-full, whole-life insurance policies
- Stocks, bonds, securities
- Real estate, including income-producing property
- Works of art, special collections
- Retirement plans
- Mineral or timber rights
- Purchase of endowment life insurance policies
- Business assets

Planned Giving Options

Charitable Will Bequest

Bequeath gifts of real estate, cash, or other property as a last will and testament with the knowledge that it will benefit a charitable cause.

Charitable Living Will

Provide for eventual gifts or real estate, cash or other property knowing that all or part of the assets may be returned upon request.

Charitable Gift Annuity

Receive fixed annual payments for life which, for a period of time, may be partially free of taxes, as well as provide an initial income tax deduction.

Charitable Remainder Trusts

May bypass capital gains tax at the time the trust is created, and may receive federal estate tax savings.

Charitable Lead Trust

Transfer assets to heirs with little or no real estate and gift taxes.

Life Insurance Policies

After a policy is no longer needed for its intended use, feel the satisfaction of giving to a charitable beneficiary.

Endowment Life Insurance Policies

Make a charitable gift to an organization which purchases policy in donor's name. When policy becomes self-funding, it is then designated to a beneficiary consistent with donor's wishes.

Gifts of Appreciated Property

Includes real estate, personal property, pension or retirement funds, and stocks and marketable securities.
